Ms. Brown is an experienced executive with more than 25 years in the payments industry, including merchant acquiring, consumer and commercial payment products, payment processing and merchant acceptance.

Ms. Brown is the recipient of the Electronic Transactions Association's 2015 Distinguished Payments Professional award, an award which recognizes industry leaders that contribute to positive change and best practices in the payments industry. In addition, Ms. Brown sat on the Board of Vital Processing Solutions, which provided merchant acquiring processing services to U.S. financial institutions (and is now wholly-owned by TSYS). She also served as a Board Director on the Transition Board of Acxsys Corporation, guiding Interac debit network strategies in Canada from 2008 to 2010.

Ms. Brown is currently enrolled in the Directors Education Program at the Institute of Corporate Directors, and holds a Master's degree in Business Administration from the Schulich School of Business at York University in Toronto.
